ORDINANCE NO. 9, SERIES 2010

AN ORDINANCE TAKING FORMAL ACTION TO PARTICIPATE IN THE NOVEMBER 2, 2010 EAGLE COUNTY COORDINATED ELECTION AND AUTHORIZING THE MAYOR OF THE TOWN OF MINTURN TO ENTER IN TO AND SIGN ANY NECESSARY INTERGOVERNMENTAL AGREEMENTS IN ORDER TO PARTICIPATE AND CONTRACT FOR COORDINATED ELECTION SERVICES

WHEREAS, Pursuant to C.R.S. 1-7-116(5) the Town of Minturn must take formal action to participate in an election that will be coordinated by the county clerk and recorder and shall notify the county clerk and recorder in writing not less than 100 days prior to the election; and

WHEREAS, The County of Eagle office of the Clerk and Recorder will require the use of an Intergovernmental agreement to manifest the coordinated election

WHEREAS, it is in the mutual interest and is required by the State of Colorado that The Town of Minturn and the Eagle County Clerk and Recorder coordinate for election services when the desired election is to be a TABOR election held in November of a given year; and.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MINTURN, COLORADO:

Section 1. The Mayor is authorized to execute such documents and to do such other acts and things as may be necessary or advisable in association with the execution of the election and delivery of an Intergovernmental Agreement with the County Clerk and Recorder.

Section 2. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance; and the Town Council hereby declares it would have passed this ordinance, and each part, section, subsection, sentence, clause or phrase thereof, regardless of the fact that any one or more parts, sections, subsections, sentences, clauses or phrases be declared invalid.


Section 3. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper for the health, safety and welfare of the Town of Minturn and the inhabitants thereof.

Section 4. The repeal or the repeal and reenactment of any provisions of the Minturn Municipal Code as provided in this ordinance shall not affect any right that has accrued, any duty imposed, any violation that occurred prior to the effective date hereof, any protection commenced, nor any other action or proceeding as commenced under or by virtue of the provision repealed or repealed and reenacted. The repeal of any provision hereby shall not revive any provision or any

ordinance previously repealed or superseded unless expressly stated herein.


