**AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 1
OF THE MINTURN MUNICIPAL CODE ADOPTION OF
THE COLORADO MUNICIPAL ELECTION CODE FOR
MUNICIPAL ELECTIONS WITHIN THE TOWN OF
MINTURN, COLORADO**

THE TOWN OF MINTURN, COLORADO ORDAINS:

Section 1. Amendment. Minturn Municipal Code, Chapter 2, Articles 1 are amended as follows:

**ARTICLE I
Elections**

- **Sec. 2-1-20. - Write-in candidate affidavit.**

No write-in vote for any municipal office shall be counted unless an affidavit of intent has been filed with the Town Clerk by the person whose name is written in ~~prior to twenty (20) days before the day of the election~~ meeting the requirements of the Colorado Municipal Election Code, C.R.S. 31-10-306 indicating that such person desires the office and is qualified to assume the duties of that office if elected.

- **Sec. 2-1-30. - Election may be cancelled.**

(a) If the only matter before the voters is the election of persons to office and if, ~~at the close of business on the nineteenth day before the election as outlined by the Colorado Municipal Election Code, Article 10 of Title 31, C.R.S,~~ there are not more candidates than offices to be filled at such election, including candidates filing affidavits of intent as set forth in Section 2-1-20 above, the Town Clerk, if instructed by resolution of the Town Council either before or after such date, shall cancel the election and the candidates, by resolution of the Town Council, shall be declared to be elected.




