WHEREAS, the Town of Minturn lists Natural Resources as a goal and strategy within the 2009 Community Plan.


WHEREAS, the Town of Minturn supports the larger Colorado community facing drought conditions of varying degrees.

THE TOWN OF MINTURN AS FOLLOWS:**



ATTACHMENT A

VOLUNTARY WATER REDUCTIONS* ARE RECOMMENDED AS FOLLOWS:

OUTDOOR WATER USE SCHEDULE

DAY	ADDRESSES THAT MAY WATER	TIMES
Monday	No outdoor water use	Before 10am or After 4pm (Midnight to 10am Or 4pm to midnight)
Tuesday	Odd	
Wednesday	Even	
Thursday	Odd	
Friday	Even	
Saturday	Odd	
Sunday	Even	

WATER USE RECOMMENDATIONS

- Adhere to the odd/even outdoor water use schedule based on the last digit in your street address.
- The watering day is from midnight to midnight.
- Hoses should have water saving shutoff nozzles to prevent free running water.
- Water shall be used for beneficial purposes only.
- Minimize evaporation by watering when winds are calm and temperatures are cool.
- Install a rain shutoff switch
- Adjust irrigation schedules at least monthly, based upon water and plant needs.
