

**TOWN OF MINTURN
RESOLUTION 04 – SERIES 2018**

A RESOLUTION OF INTENT TO DELIBERATE AND DESIGNATE AREAS AND/OR ACTIVITIES OF STATE INTEREST WITHIN THE TOWN OF MINTURN; SETTING THE DATE, TIME, AND PLACE OF A PUBLIC HEARING REGARDING SAID DELIBERATION AND DESIGNATION; AND ORDERING THE PUBLICATION OF NOTICE OF SAID PUBLIC HEARING.

WHEREAS, the Town of Minturn (“Minturn” or the ‘Town”) has the legislative authority to control land uses and development within its boundaries for the best interest of the Town, its inhabitants, and its visitors; and

WHEREAS, the Minturn Town Council has specific authority to consider and designate areas and activities of state interest and to adopt guidelines and regulations for the administration of such areas and activities of state interest pursuant to C.R.S. § 24-65.1-101, *et seq.*; and

WHEREAS, the Town Council finds and declares that due to the Town’s particular location, geographical and geological constraints, and historic and natural character, it is appropriate to deliberate the reasonable regulation of areas and activities of state interest within the Town for potential designation; and

WHEREAS, it is necessary to set a date, time, and place for a public hearing regarding the designation of areas and activities of state interest, and to provide public notice of the same.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MINTURN, COLORADO:

Section 1: The Town Council hereby declares its intent to deliberate the potential designation of areas and/or activities of state interest for local regulation consistent with C.R.S. § 24-65.1-101 *et seq.*, including the designation and regulation of major facilities of public utilities, municipal and industrial water projects, and major new domestic water and sewage systems and extensions.


Section 2: A public hearing regarding the designation of areas and/or activities of state interest is hereby set for Wednesday, February 21, 2018 at 6:30 PM in the Town Hall of Minturn Colorado, 302 Pine Street, Minturn, Colorado 81645.

Section 3: The Town Clerk shall publish and post notice of said public hearing no less than 30 or more than 60 days before said time and date.


Section 4: This Resolution shall be effective immediately upon adoption.

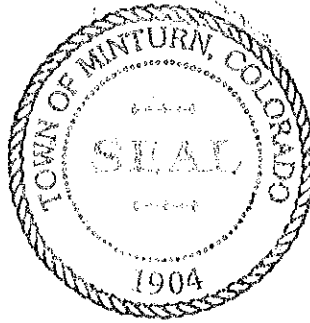


