Voluntary Water Reductions are in effect and recommended as follows:

OUTDOOR WATER USE SCHEDULE

TIMES: Before 10am or after 4pm (midnight to 10am or 4pm to midnight)

ADDRESSES that may water: ODD or EVEN

Monday – no outdoor water use

Tuesday, Thursday, Saturday – ODD

Wednesday, Friday, Sunday – EVEN

WATER USE RECOMMENDATIONS:

- Adhere to the odd/ even outdoor water use schedule based on the last digit in your street address.
- The watering day is from midnight to midnight.
- Hoses should have water saving shutoff nozzles to prevent free running water.
- Water shall be used for beneficial purposes only.
- Minimize evaporation by watering when winds are calm, and temperatures are cool.
- Install a rain shutoff switch
- Adjust irrigation schedules at least monthly, based upon water and plant needs.

STAGE 2 FIRE RESTRICTIONS IN EFFECT.

The Town of Minturn has extended the Eagle County Emergency Management “Stage 2” fire restrictions to all parts of Minturn pursuant to Minturn Municipal Code 7-10-10. These restrictions will remain in effect until conditions warrant change and may be expanded as necessary. These temporary restrictions include:

- NO Campfires are allowed.
- NO fires of any type except those using pressurized liquid or gas.
- NO smoking except within an enclosed vehicle or building.
- NO use of explosive materials, including explosive targets
- NO welding or operation of an acetylene or other similar torch with open flame, or any other spark producing device, except from an area that has been cleared of vegetation
- NO operation of any internal combustion engine without a spark arresting device properly installed and in working order.
- NO Use of motor vehicles off National Forest system roads, except when parking in an area devoid of vegetation within 10 feet of the roadway and except for parking overnight in developed campgrounds and at trailheads.

Construction Use Tax Questions & Answers

Learn more; open house scheduled for Thursday, August 9, 5:30-6:30 at town hall, 302 Pine St.

Why is the Town of Minturn considering a construction use tax? To provide for a dedicated source of revenue to fund capital improvement expenditures. Capital expenditures are currently funded out of our already strained general fund. By providing this source of revenue to the town, we eliminate the demand on the general fund to pay for items such as roads, lighting, sidewalks, land, buildings, machinery and equipment.

What is a construction use tax? Generally, a use tax is levied on the privilege of using or otherwise consuming tangible personal property within a city or county for which no sales or use tax has been previously paid. It is considered complementary to a sales tax, and **is applied where the product or materials are used, regardless of where the property was purchased.** For example, the Town of

Minturn’s construction use tax is levied on construction material used in Minturn regardless of where the supplier is located.

A use tax may be applied generally to all tangible personal property used or consumed within a municipality or its application may be limited to vehicles and/or construction and building materials.

The Town of Minturn use tax is limited to construction and building materials.

LET’S TALK WATER:

Minturn continues to gather information for water options moving forward. **The Council requests community feedback with comments, questions and conversations.** Below are three different water source options for review.

Water quality data is included specifically showing the a few metals at different diversion points. The Eagle River has significantly higher metals levels at the Minturn diversion point but would still be treatable with a membrane plant. The Eagle River runs at over 10 NTU (turbidity level). This means for any water option involving taking water from the Minturn/Eagle River diversion a new water treatment plant would be needed since the slow sand filtration system (even in excellent working condition) cannot filter through such high turbidity.

WATER SOURCE OPTIONS

There is no scenario above 1600 people where a secondary water source isn’t added to the system. Minturn residents’ water bill is currently \$84.03 / month. All numbers are rough estimates.

1600 PEOPLE (MINIMUM GROWTH)

- Still required to serve school dist. development
- Reasonable infill development
- No Bolts reservoir
- Still need membrane WTP \$5M
- Still need Dowd junction sales tax revenue (waterline town to Dowd: \$2M)
- Still pay \$100,000/year for storage
- Still need larger storage tank \$1M
- Still need secondary water source \$2M

Estimated improvements total = \$10M
 Estimated monthly water bill increase = \$50/month for 20 years (per SFE)

RESERVOIR WITH INTERCONNECT: DOWD TO NORTH TOWN OR TANK

- Do not need to upgrade to a membrane WTP immediately \$.5m (tap fees from development to help pay this cost)
- Able to serve growth scenarios including Dowd Jct
- Full size bolts reservoir (1210af)
- Get 160 af storage

- May save \$100,000/year on storage
- Wholesale water purchase from ERWSD with interconnect to north town or tank: Paid by 3rd party developers (Growth pays for Growth)
- Different areas of town served with different sources of water

Rate impacts yet to be determined

MINI RESERVOIR (NO INTERCONNECT):

- Minturn builds “mini reservoir” with 320 af (does not include operations & maintenance) 10M
 - Purchase reservoir site 3M
 - New membrane WTP 5M
 - Pipeline from bolts to WTP 2M
 - May save \$100,000/year on storage
 - Build pipeline to Dowd \$2M
 - Estimated improvements total=20M
- Estimated monthly water bill increase = \$100/month for 20 years (Per SFE)
